Cookie Policy ILC Our House

What are cookies?

As is common practice with almost all professional websites, this website uses cookies, which are small files downloaded to your computer to enhance your experience. How do we use cookies?

Disable cookies

Account related cookies

If you create an account with us, we will use cookies for the management of the registration process and general administration. These cookies will generally be deleted when you log out, however, in some cases they may remain afterwards to remember your site preferences when you log out.

Cookies related to login

We use cookies when you are logged in so that we can remember that action. This saves you from having to log in every time you visit a new page. These cookies are normally removed or cleared when you log out to ensure that you can only access restricted features and areas when you log in.

Cookies related to email newsletters

This site offers newsletter or email subscription services and cookies may be used to remember if you are already registered and whether to show certain notifications valid only for subscribed / non-subscribed users.

Survey related cookies
